(Curriculum)

Being enrolled in the school for at least two years, earning the required credits by completing the required courses as a requirement for completion as stipulated in this degree program, receiving the necessary research guidance, passing the master's thesis examination and the final exam. However, those who have achieved excellent achievements may reduce the period of the enrollment to one year minimum.

(Requirements) □

Students are required to obtain 30 or more credits as follows,

- (1) General Foundation Subjects Compulsory Subject 14credits (5subjects below)
  - Common Subjects: Introduction to Social Medicine
  - Subjects for Public Health—General Foundation Subjects: Introduction to Epidemiology, Biostatistics, Basic, Dissertation in Public Health Sciences, Seminar: Epidemiology and Biostatistics
- (2) Subjects for Public Health—Major Subjects: Compulsory Subject 9credits (7subjects below)
  - Lecture on Health Behaviorl Science, Epidemiology, Biostatistics, Advanced, Health Care Policy and Management, Health Service Administration, Health Economics, Introduction to health services research
- (3) Subjects for Public Health: General Foundation Subjects and Major Subjects, Elective Compulsory Subject 6credits
- (4) Subjects for Public Health: General Foundation Subjects and Major Subjects, Graduate General Education 1credit or more

(Notice)

In addition to the above, subjects designated by the degree program may be included in public health related subjects. If it is recognized as educationally beneficial, credits obtained by taking courses in other degree programs within the range specified for each degree program up to a maximum of 10 credits can be recognized as credits required for completion.
