- (1) Six credits from advanced foundation subjects of Human Care Science or Public Health related subjects.
 - Special Lecture on Human Care Science I to III (Three credits) and Special Lecture on Public Health I to III (Three credits)
- (2) Six credits from advanced subjects of Human Care Science related subjects Seminar on Human Care Science (Three credits) and Research in Human Care Science (Three credits)
