[Completion Requirements]

- ① Publish at least one English-language original research article*1 in a peer-reviewed academic journal as the first author.
- ② Earn 30 or more credits by registering for Compulsory and Elective subjects*2 designated in Doctral Program in Medical Sciences
- 3 Pass the mid-term evaluation*3.
- 4 Pass the dissertation defense.
- ⑤ Enroll for 4 years. Students who are judged to have made exceptional achievement may be eligible for early completion after 3 years of enrollment.
- *1 Case reports and brief letters are typically not regarded as original research articles. Research papers already publ ished before enrollment in the doctoral program may not be used to fulfill this requirement. The paper(s) to fulfill this requirement should be published or accepted for publication by the time to submit the final version of doctoral dissertation.
- *2 It is recommended to filfill this requirement by the end of the second year.
- *3 It is recommended to take the mid-term evaluation in the first half of the third year. Those who could not fulfill ② by the end of the second year would take the mid-term evaluation later.

[Model for Registration]

Earn 30 credits or more by the end of second year, by registering following subjects.

- i) 13 credits from Compulsory Subjects.
- ii) 17 credits from Elective Subjects (shaded). It is strongly recommmended to take Lecture/Seminar I and II, and also Practice I and II in the reseach area which your supervisor is in charge. (up to 12 credits in total).
- iii) In addition to i) and ii), up to 25 credits, take five or more credits by registering for Elective subjects, and earn 30 credits or more in total, but not more than 50 credits.
- iv) As an example of iii), E-learning lectures from "Kanto Academic Alliance Program for Fostering Cacer Professionals", Compulsory Subjects (8 credits), General subjects for each course (1 credit or more) and Elective Compulsory subjects (4 credits or more) can be included (13 credits or more in total). Note that these subjects should be taken as a set. Registration for individual subjects is not acceptable. If a student earns 25 credits from i) and ii), the number of credits to earn would be 38 credits or more with registration of Ganpro Cancer Program.
- v) Interdisciplinary Foundation Courses/ Graduate General Education Courses may be included, preferably 2 credits, maximumly 3 credits, as Elective subjects described in iii).
